- on 24.04.2023, the total amount of **5,222** Shares for the total value of PLN **65,055.16** with an average unit share price of PLN **12.45**. These shares constitute 0.009% of the share capital of the Company and entitle to **5,222** votes at the General Meeting of the Company, which constitutes 0.009% of the total number of votes.

- on 25.04.2023, the total amount of **5,293** Shares for the total value of PLN **66,339.18** with an average unit share price of PLN **12.56**. These shares constitute 0.009% of the share capital of the Company and entitle to **5,293 4** votes at the General Meeting of the Company, which constitutes 0.009% of the total number of votes.

- on 26.04.2023, the total amount of **4,794** Shares for the total value of PLN **60,462.92** with an average unit share price of PLN **12.61**. These shares constitute 0.008% of the share capital of the Company and entitle to **4,794** votes at the General Meeting of the Company, which constitutes 0.008% of the total number of votes.

- on 28.04.2023, the total amount of **4,700** Shares for the total value of PLN **60,731.24** with an average unit share price of PLN **12.89**. These shares constitute 0.008% of the share capital of the Company and entitle to **4,700** votes at the General Meeting of the Company, which constitutes 0.008% of the total number of votes.
