4. *If you (e.g. as an asset manager, trustee or otherwise) act in the name of more than one shareholder, you are required to submit for each party a separate proxy.*
5. *In addition to this proxy, the authorized representative must also present the depository certificate as of the Record Date (6th November 2020) as required by the notice of the general meeting.*
